RESOLUTION NO. 1299

A RESOLUTION EARNESTLY REQUESTING THE HONORABLE MINISTER  
OF PUBLIC WORKS AND HIGHWAYS TO CONVERT THE ORMOC MUNICIPAL  
PORT INTO A NATIONAL PORT.

"WHEREAS, it would be to the greater benefit of the Ormoc port  
were it to be converted into a national port considering the ever-  
growing volume of coastwise and export trade being presently handled  
as well as the growing number of vessels calling at the port of Ormoc  
with the establishments of industrial plants, commercial houses and  
other business enterprises ever since the harnessing of the Tugonon  
hot springs as a geothermal power source;

"WHEREAS, despite the congestion in the port of Ormoc nothing  
so far has yet been done by the Philippine Ports Authority to ease  
it up and improve the condition of the port;

"NOW, THEREFORE, on motion of Kagawad Larrazabal, seconded by  
Mga Kagawad Mendola and Santiago, jointly; be it

"RESOLVED, to earnestly request the Honorable Minister of Pub-  
lic Works and Highways to convert the Ormoc municipal port into a  
national port; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each  
to the Honorable Minister of Public Works and Highways, Port Area,  
Manila; the Regional Director, Ministry of Public Works and Highways,  
Kandahug, Palo, Leyte; and the City Engineer, Ormoc City;
