RESOLUTION NO. 1301

A RESOLUTION TO AUTHORIZE THE CITY TREASURER TO CAUSE THE INSTALLATION OF TELEPHONE FOR THE FIRE SUB-STATION ON CORNER SAN PEDRO AND OBRERO STREETS OUT OF ANY FUND AVAILABLE.

"WHEREAS, the Fire Station Commander in his letter of even date has reported that his firemen with one fire truck have been occupying the newly constructed fire sub-station on corner San Pedro and Obrero streets since last January 6 but they lack one very important facility - a telephone connection for them specially for response to emergency call;

"NOW, THEREFORE, on motion of Kagawad Torrevillas, seconded by Kagawad Mendola; be it

"RESOLVED, to authorize the City Treasurer to cause the installation of telephone for the Ormoc City Fire Sub-station on corner San Pedro and Obrero streets availing himself of any fund for this purpose; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the City Treasurer, the Fire Station Commander, and the General Manager of the Ormoc City Telephone Co., all of this city;
