RESOLUTION NO. 1306

A RESOLUTION REQUESTING THE HONORABLE CITY MAYOR TO PERMIT THE GIRL
SCOUTS OF THE PHILIPPINES, ORMO CITY CHAPTER, TO HOLD A 3-DAY
"PINTAKASI" ON FEBRUARY 10, 11 and 12, 1983, AT THE VALENCIA
SPORTS CENTER, THE PROCEEDS OF WHICH AMOUNTING TO P1,500.00
SHALL BE APPROPRIATED FOR VARIOUS GSP PROJECTS AND CAMPOALS

"WHEREAS, the Area V Girl Scouts Coordinator in her letter of
January 11, 1983, has requested a resolution for a three-day 'pin-
takasi' on February 10, 11 and 12, 1983, at the Valencia Sports Cen-
ter to raise funds for the various projects of the GSP Ormo City
Chapter and camporals this year;

"WHEREAS, this august Body finds the request meritorious consi-
dering that the local Girl Scouts organization is in dire need of
funds and that the proceeds usually amounting to P1,500.00 will cer-
tainly augment its funds reserved;

"NOW, THEREFORE, on motion of Kagawad Samson, seconded jointly
by Hga Kagawad Torrevillas, Larrazabal and Hermosilla; be it

"RESOLVED, to request the honorable City Mayor to permit the
Girl Scouts of the Philippines, Ormo City Chapter, to hold a 3-day
'pintakasi' on February 10, 11 and 12, 1983, at the Valencia Sports
Center, a duly licensed establishment, the proceeds of which in the
amount of P1,500.00 shall be appropriated for various GSP projects

City; the Area V Girl Scouts Coordinator, the Station Commander of
