RESOLUTION NO. 1308

A RESOLUTION TO AUTHORIZE THE CITY TREASURER TO CHARGE AGAINST
CURRENT APPROPRIATIONS ON COMMUNICATION SERVICES AND AID TO
CFI THE AGGREGATE SUM OF ₱7,921.50 TO SETTLE OUTSTANDING
OBLIGATIONS ON TELEPHONE SERVICES OF OFFICES AND RESIDENCES
OF CITY PUBLIC OFFICIALS FOR THE MONTHS OF OCTOBER, NOVEMBER
AND DECEMBER, 1982, AS RECOMMENDED BY THE CITY BUDGET OFFICER

"WHEREAS, the City Budget Officer has recommended that the out-
standing obligations with the Ormoc City Telephone Co., Inc., on te-
lephone services of offices and residences of city public officials,
including the Court of First Instance, amounting to ₱7,921.50 as per
statements of accounts from the telephone company covering the months
of October, November and December, 1982, be charged against current
appropriations on communication services and Aid to the Court of First
Instance;

"NOW, THEREFORE, on motion of Kagawad Besabella, seconded joint-
ly by Mga Kagawad Mendola and Hermosilla; be it

"RESOLVED, to authorize the City Treasurer to charge against cur-
rent appropriation on communications and Aid to Court of First Instance
the aggregate sum of Seven Thousand Nine Hundred Twenty-One & 50/100
Pesos (₱7,921.50) to settle outstanding obligations with the Ormoc City
Telephone Co., Inc., on telephone services of the offices and residen-
ces of city public officials, including the Court of First Instance,
for the months of October, November and December, 1982, as recommended
by the City Budget Officer; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to
the City Treasurer, the City Budget Officer, and the General Manager
of the Ormoc City Telephone Co., Inc., all in Ormoc City;
