RESOLUTION NO. 1309

A RESOLUTION TO AUTHORIZE THE CITY TREASURER TO EXTEND THE  
DEADLINE FOR PAYMENT OF MAYOR'S PERMIT FEES AND CITY  
LICENSES FROM JANUARY 20 TO JANUARY 31, 1983

"WHEREAS, it is only two days to the deadline for payment of Mayor's permit fees and city licenses but taxpayers are still overcrowding the alleys by the office of the City Treasurer such that we deem it wise and proper to extend the deadline up to the end of the month temporarily suspending for this purpose the operation of Section 1.2.-1.4 of Tax Ordinance No. 1, otherwise known as the 'Ormoc City Revenue Code of 1977', fixing the first twenty (20) days of January to pay tax obligations;

"NOW, THEREFORE, on motion of Kagawad Santiago, seconded by Kagawad Besabella; be it

"RESOLVED, to authorize the City Treasurer to extend the deadline for payment of Mayor's permit fees and city licenses from January 20 to January 31, 1983, suspending for this purpose temporarily Section 1.2.1.4 of Tax Ordinance No. 1, otherwise known as the 'Ormoc City Revenue Code of 1977'; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the City Treasurer and all his Revenue Collection Clerks, Ormoc City;  
"CARRIED UNANIMOUSLY."
