RESOLUTION NO. 1316

A RESOLUTION TO EARNESTLY REQUEST THE CITY ENGINEER TO OPEN UP A  
900-METER BARANGAY ROAD FROM BARANGAY GUINTIGUIAN TO THE  
NEAREST POINT OF THE N.I.A. ROAD IN THE MATICAA SIDE

"WHEREAS, the inhabitants of Barangay Guintiguian have been long clamoring for a feeder road to facilitate travel and transportation of their produce to the city inasmuch as up to the present they find it so difficult to travel along private roads considering that Barangay Guintiguian is circumscribed by the agricultural lands of the Frans and the Espinas and their only recourse is to avail themselves of the road constructed by the National Irrigation Administration (N.I.A.) which mostly is cumbersome for them;

"WHEREAS, after a series of inspection and survey of the situation it has been observed that the best solution to this nagging problem is to construct or open up a road from Barangay Guintiguian to the N.I.A. road, particularly, at the nearest point in the Maticaa side, which is about 900 meters distance;

"NOW, THEREFORE, on motion of Kagawad Besabella, seconded jointly by Mga Kagawad Mendola and Larrazabal; be it

"RESOLVED, to earnestly request the City Engineer to open up a 900-meter barangay road from Barangay Guintiguian to the nearest point of the N.I.A. road in the Maticaa side; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the City Engineer, the Punong Barangay of Maticaa, and the Punong Barangay of Guintiguian, all in Ormoc City;

"CARRIED UNANIMOUSLY."
