RESOLUTION NO. 1317

A RESOLUTION TO AUTHORIZE THE CITY TREASURER TO PREPARE AN INVITATION TO BID FOR THE AVAILABILITY OF A RADIO COMMUNICATIONS NETWORK IN THE CITY OF ORMOC PROVIDED THAT FUNDS FOR THE PURPOSE SHALL BE APPROPRIATED OUT OF THE CITY'S INTEREST INCOME ON TIME DEPOSIT WITH THE PHILIPPINE NATIONAL BANK.

"WHEREAS, with the unprecedented rapidity with which the City Administration has been carrying on its various programs of social and economic development it has become quite urgent that a radio communications network be made available covering strategic points of Ormoc City from where contacts can be made not only among ourselves around the city but also with the neighboring municipalities and, if possible, provinces near and far;

"WHEREAS, for this purpose the City may avail itself of the interest income on its time deposit with the Philippine National Bank which we believe is more than sufficient to cover overall expenses;

"NOW, THEREFORE, on motion of Kagawad Larrazabal, seconded jointly by Mga Kagawad Santiago and Codilla; be it

"RESOLVED, to authorize the City Treasurer to prepare an invitation to bid for the availability of a radio communications network in the City of Ormoc: Provided, However, that funds for the purpose shall be appropriated out of the City's interest income on time deposit with the Philippine National Bank; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the City Treasurer, the City Budget Officer, and the City Engineer, all in the City of Ormoc; "CARRIED UNANIMOUSLY."
