RESOLUTION NO. 1318

A RESOLUTION TO INCORPORATE SITIO ISLA VERDE INTO THE JURISDICTION  
OF BARANGAY XXVI

"WHEREAS, Isla Verde, a newly existing sitio, is found to be traversing along the boundary between Barangays XXVI and Cogon Combado such that it has not been established as to where this sitio belongs;

"WHEREAS, the ABC President, in his capacity as Chairman of the Committee on Rural Development of this august Body, who was delegated to confer and negotiate with the officials of Barangays XXVI and Cogon Combado and representatives of Sitio Isla Verde, reported that it was finally decided and agreed that Sitio Isla Verde should fall under the jurisdiction of Barangay XXVI for all intents and purposes of the barangay government and that all matters affecting said sitio shall be the concern of the mother barangay from now on;

"NOW, THEREFORE, on motion of Kagawad Hermosilla, seconded jointly by Mga Kagawad Samson and Bandalan; be it

"RESOLVED, to incorporate Sitio Isla Verde into the jurisdiction of Barangay XXVI; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the ABC President, the Punong Barangays of Barangays XXVI and Cogon Combado, and the Chief of Barangay Tanod of Isla Verde, all in Ormoc City, and also the City Development Officer;

"CARRIED UNANIMOUSLY."
