RESOLUTION NO. 1319

A RESOLUTION OF COMMITMENT TO AVAIL OF THE NATIONAL COORDINATING COUNCIL'S ASSISTANCE TO UPDATE THE COMPREHENSIVE DEVELOPMENT PLAN OF ORMOC CITY AND AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN THE MEMORANDUM OF AGREEMENT WITH THE MINISTRY OF HUMAN SETTLEMENTS FOR THE PURPOSE.

"WHEREAS, the City of Ormoc is desirous to avail itself of the services and assistance under the initiative and through the combined efforts of the National Economic Development Authority (NEDA) and the Ministries of Human Settlements (MHS), Local Government (MLG), Finance (MOF) and the Budget (MOB) which are presently engaged in planning activities for which purpose the government has established the National Coordinating Council (NCC);

"WHEREAS, the Ministry of Human Settlements, for and in behalf of the National Coordinating Council, has prepared a Memorandum of Agreement with the Honorable City Mayor, for and in behalf of the Government of Ormoc City, to be signed by both parties for availment of the former's city planning and zoning assistance program and services;

"NOW, THEREFORE, on motion of Kagawad Besabella, seconded jointly by Mga Kagawad Bandalan and Hermosilla; be it

"RESOLVED, to commit Ormoc City to avail itself of the services and assistance of the National Coordinating Council to update the Comprehensive Development Plan of Ormoc City and do, as this Body hereby does, authorize the Honorable City Mayor to sign the Memorandum of Agreement with the Ministry of Human Settlements for the purpose; and

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the Honorable Minister of Human Settlements, the Honorable Minister of Economic Planning, the Honorable Minister of Local Government, the Honorable Minister of Finance, the Honorable Minister of the Budget, the Honorable Chairman of National Coordinating Council, all in Metro Manila; the City Development Coordinator and the City Development Officer, both in Ormoc City;
