A RESOLUTION TO AUTHORIZE THE CITY TREASURER TO CHARGE AGAINST
CURRENT APPROPRIATIONS ON FUELS, OILS, SPARE PARTS, AND
TRAVEL AND TRANSPORTATION OF THE CITY ENGINEERING OFFICE
THE AGGREGATE SUM OF ₱477.30 TO SETTLE OUTSTANDING OBLIGA-
TIONS INCURRED LAST CALENDAR YEAR.

"The Sangguniang Panlungsod ng Ormoc, on motion of Kagawad Besa-
bella, seconded jointly by Mga Kagawad Bandalan and Hermosilla;

"RESOLVED, to authorize the City Treasurer to charge against cur-
rent appropriations on Fuels, Oils and Spare Parts the sum of Two Hun-
dred Seventy-One & 25/100 Pesos and on Travel and Transportation Two
Hundred Six & 05/100 Pesos (₱206.05), or the aggregate sum of Four
Hundred Seventy-Seven & 30/100 Pesos (₱477.30) of the City Engineer-
ing Office, said sum or so much thereof as may be necessary to be made
available to settle outstanding obligations of said office incurred
last calendar year; and

"RESOLVED, FURTHER, to furnish a copy of this resolution each to
the City Treasurer, the City Engineer, the Ormoc Rizal Hardware and
General Merchandise, the UN Hardware & Auto Supply Co., and Engr.
Crispin B. de la Victoria, Assistant City Engineer, all in Ormoc City;
