RESOLUTION NO. 1322

A RESOLUTION EARNESTLY REQUESTING THE NATIONAL ELECTRIFICATION ADMINISTRATION TO FACILITATE THE RELEASE OF FUNDS AND MATERIALS TO LEYECO V FOR THE REVAMPING OF THE TRANSMISSION AND DISTRIBUTION LINES IN THE AREA

"WHEREAS, it is of common knowledge that the service of LEYECO V is way below the minimum needs for efficient electric current distribution to member-consumers such that a lot of breakage has been incurred by several appliances on account of low voltage and intermittent brownouts or blackouts without warning;

"WHEREAS, the suffering public is now beginning to reminisce the good old days when power failure was never known and much less experienced with the exteedingly efficient service rendered by the Ormoc Electric Company;

"WHEREAS, from the officers and staff of LEYECO V who were requested to appear before this august Body, we have learned that the causes of all these electrical troubles lie in the deficiency along the transmission and distribution lines of the system whereby voltage goes down to as low as 150 in the early evening resulting in breakage of appliances and, in consequence, high costs of appliance maintenance;

"WHEREAS, LEYECO V management is up to now still waiting for the release of funds and the necessary materials from the central office with which to revamp the present transmission and distribution lines of the system in order to provide once and for all a better, if not excellent, service to the consuming public;

"NOW, THEREFORE, on motion of Kagawad Hermosilla, seconded jointly by Mga Kagawad Tugonon and Larrazabal; be it

"RESOLVED, to earnestly request the National Electrification Administration to facilitate the release of funds and materials to LEYECO V with which to revamp the transmission and distribution lines in the area served by the Cooperative; and be it (RES. NO. 1322, S.P. ORMOC, PAGE TWO)

"RESOLVED, FURTHER, to furnish a copy of this resolution each to Gen. Pedro Dumol, Administrator, National Electrification Administration, 10050 Quezon Avenue, Quezon City; the President, Board of Directors, and the General Manager, both of LEYECO V, in the City of Ormoc;
