RESOLUTION NO. 1323

A RESOLUTION TO PROTEST THE 10% RATE INCREASE OF THE NATIONAL POWER CORPORATION CONSIDERING THAT LEYECO V DOES NOT NEED TO SERVE OIL-BASED ELECTRICITY TO ITS MEMBER-CONSUMERS

"WHEREAS, the National Power Corporation has included LEYECO V in the imposition of 10% increase in rates although the cooperative is availing itself of the geothermal energy from the Tuñongan power plant in Ormoc City and does not need to serve its member-consumers with oil-based electricity;

"NOW, THEREFORE, on motion of Kagawad Hermosilla, seconded by Kagawad Tugonon; be it

"RESOLVED, to protest the 10% rate increase imposed by the National Power Corporation considering that LEYECO V is availing itself of the geothermal energy from the Tuñongan power plant in Ormoc City and does not need to serve its member-consumers with oil-based electricity; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to His Excellency, President Ferdinand E. Marcos, Malacañang, Hon. Gabriel Y. Itchon, President, National Power Corporation, Quezon Ave. cor. BIR Road, Dilliman, QC, and Col. Pedro Dumol, Administrator, National Electrification Administration, 10050 Quezon Ave., QC, all in Metro Manila; Mr. Climaco Evangelista, President, Board of Directors, and Mr. Rosalino M. Culalic, General Manager, both of LEYECO V, Ormoc City;
