RESOLUTION NO. 1324

A RESOLUTION RESPECTFULLY REQUESTING AMBASSADOR ROBERTO BENEDICTO TO REQUEST PROPER AUTHORITIES THAT CLOUD-SEEDING BE MADE OVER ORMOG CITY TO INDUCE RAINS FOR SURVIVAL OF SUGARCANE AND OTHER PLANTATIONS IN THE AREA

"WHEREAS, this long drought has very much affected our sugarcane and other plantations and if this will go on it won't be long until our crops will be greatly damaged that will certainly bring about so much economic dislocation not only in the City of Ormoc but also in the neighboring towns;

"WHEREAS, quite a number of farmers have made representations before this august Body for the feasibility of requesting proper authorities in the National Government, through the Honorable Ambassador Roberto Benedicto, for some cloud-seeding over Ormoc City with the fervent hope for rains to be induced in order that our crops will survive the on-slaught of this drought;

"NOW, THEREFORE, on motion of Kagawad Tugonon, seconded jointly by Mga Kagawad Torrevillas and Larrazabal; be it

"RESOLVED, to respectfully request the Honorable Ambassador Roberto Benedicto to request proper authorities for cloud-seeding over Ormoc City to induce rains for the survival of sugarcane and other plantations in the area for the benefit of our farmers; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the Honorable Ambassador Roberto Benedicto, Chairman, Philippine Sugar Commission, North Avenue, Dilliman, Quezon City; the President, Ormoc Sugarcane Planters Association, (OSPA), the President, Occidental Leyte Sugarcane Farmers Association (OLSUFA), and the President United Farmers (UNIFARM), Inc., all in Ormoc City;

"CARRIED UNANIMOUSLY."
