RESOLUTION NO. 1330

A RESOLUTION TO AUTHORIZE THE CITY TREASURER TO SET ASIDE THE SUM
OF THREE HUNDRED FIFTY EIGHT PESOS (P358.00) OUT OF THE 20%
DEVELOPMENT FUND TO BE MADE AVAILABLE FOR REGISTRATION FEES
AND TRANSPORTATION OF TWO (2) KB PARTICIPANTS FOR THE REGIONAL
APPROPRIATE TECHNOLOGY TRAINING SEMINAR IN PAWING, PALO, LEYTE,
AS AUTHORIZED BY THE MINISTRY OF LOCAL GOVERNMENT.

"WHEREAS, two members of the City Federation of Kabataang Ba-
rangays (KKB) are participating in the Live-in Regional Appropriate
Technology (APPROTECH) Training Seminar on March 1-5, 1983, at the
NIA Regional Training Center, Pawing, Palo, Leyte, which primarily
aims to provide the participants orientation and skills necessary
in the planning and implementation of APPROTECH projects;

"WHEREAS, for this purpose the use of a portion of the 20% De-
velopment Fund, among other available local funds, is authorized per
unnumbered Memo Circular dated February 10, 1983, of the Ministry
of Local Government, with which the sum of P358.00 would be suffi-
cient for the two participants for registration fee of P150.00 and
transportation fare of P29.00 each;

"NOW, THEREFORE, on motion of Kagawad Codilla, seconded joint-
ly by Mga Kagawad Tugonon and Torrevillas; be it

"RESOLVED, to authorize the City Treasurer to set aside the sum
of Three Hundred Fifty-Eight Pesos (P358.00) out of the 20% Develop-
ment Fund, said sum or so much thereof as may be necessary to be made
available for registration fees and transportation fares of two (2)
KB participants for the Regional Appropriate Technology Training Se-
minar in Pawing, Palo, Leyte, March 1-5, 1983; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each
to the Regional Manager, Kabataang Barangays, Tacloban City; the
City Treasurer and the President, Federation of Kabataang Barangays,
both of this city;

"CARRIED UNANIMOUSLY."
