IMPLEMENTATION OF THE CITY POPULATION PROGRAM BY THE  
CITY POPULATION OFFICE.

"WHEREAS, our contract with the Commission on Population for the  
implementation of the City Population Program by our City Population  
Office needs to be renewed wherein the sharing for this year will be  
60% for the City Government and 40% to be shouldered by the Commission  
even as the approved 1983 General Fund Budget for the City Population  
Office meets the contract requirements;

"RESOLVED, to authorize the Honorable City Mayor, for and in be-  
half of the Government of Ormoc City, to sign the contract renewal with  
the Population Commission for the implementation of the City Population

Population Officer, the City Treasurer, and the City Budget Officer,
