RESOLUTION NO. 1337

A RESOLUTION IMPOSING NO OBJECTION TO THE GRANTING OF A SPECIAL PERMIT TO THE GIRL SCOUTS OF THE PHILIPPINES AND THE BUKLOD BAYAN CHESS FEAST '83 TO JOINTLY SPONSOR A THREE-DAY "PINTAKASI" ON APRIL 14-16, 1983, IN CONNECTION WITH THEIR RESPECTIVE FUND-RAISING CAMPAIGNS, SUBJECT TO PARAGRAPH 28 OF THE REVISED RULES AND REGULATIONS FOR THE IMPLEMENTATION OF PRESIDENTIAL DECREE NO. 449 ISSUED BY THE HEADQUARTERS PHILIPPINE CONSTABULARY

"WHEREAS, the Girl Scouts Coordinator, Area V, has requested a resolution for a 3-day 'pintakasi' at the Madongholan Cockpit to raise funds for the forthcoming summer camp;

"WHEREAS, the Chairman of the Buklod Bayan Chess Feast '83 has, likewise, requested the same resolution to include them in the granting of permit to hold said 'pintakasi' on April 14, 15, 16, 1983, to raise funds for the 1983 chess tournament;

"NOW, THEREFORE, on motion of Kagawad Sison, seconded by Kagawad Codilla; be it

"RESOLVED, to interpose no objection to the granting of a special permit to the Girl Scouts of the Philippines and the Buklod Bayan Chess Feast '83 to jointly sponsor a three-day 'pintakasi' on April 14, 15 and 16, 1983, at the Madongholan Cockpit, a duly licensed establishment in Ormoc City, in connection with their respective fund-raising campaigns, subject to paragraph 28 of the Revised Rules and Regulations for the implementation of Presidential Decree No. 449 issued by the Headquarters Philippine Constabulary; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the Regional Director, Philippine Gamefowl Commission, Tacloban City; the Station Commander, CCINF, the Girl Scouts Coordinator, Area V, the Chairman, Buklod Bayan Chess Feast '83, and the Manager, Madongholan Cockpit, all in Ormoc City;
