A RESOLUTION ADOPTING RESOLUTION NO. 1005 OF THE HONORABLE
SANGGUNIANG PANLUNGSOD NG DABAW

"WHEREAS, the Honorable Sangguniang Panlungsod ng Dabaw has furnished for our support a copy of its Resolution No. 1005 of February 11, 1983, requesting the First Couple of the Land in their respective official capacities to stop the proposed increase in the prices of fuel and other oil products as recommended by government economic planners for purposes of raising funds for government operations, as the end-result will add burden to the common mass of our people as experienced in the past, considering the economic conditions prevailing in the country today;

"WHEREAS, we concur in the embodiment of the resolution of Davao City Sanggunian even as we adhere to the contention advanced therein;

"NOW, THEREFORE, on motion of Kagawad Hermosilla, seconded by Kagawad Bandalan; be it

"RESOLVED, to adopt Resolution No. 1005 of the Honorable Sangguniang Panlungsod ng Dabaw and do, as this Body hereby does, most respectfully request His Excellency, President Ferdinand E. Marcos, and the Honorable First Lady and Minister of Human Settlements, Madam Imelda Romualdez-Marcos, to stop the proposed increase in the prices of fuel and other oil products as recommended by the government economic planners inasmuch as the end-result will only add burden to the common mass of our people; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to His Excellency, President Ferdinand E. Marcos, and the Honorable First Lady and Minister of Human Settlements, Madam Imelda Romualdez-Marcos, both in Malacañang, Metro Manila, and the Honorable Sangguniang Panlungsod, Davao City;
