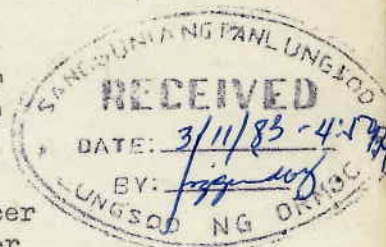

RESOLUTION NO. 1339

A RESOLUTION TO AUTHORIZE THE CITY TREASURER TO CHARGE AGAINST
THE CURRENT APPROPRIATION ON OFFICE SUPPLIES OF THE CITY
HEALTH DEPARTMENT THE SUM OF FOUR HUNDRED THIRTEEN & 50/100
PESOS (P413.50) TO SETTLE OUTSTANDING OBLIGATIONS WITH THE
LINA'S TEXTILES.
