RESOLUTION NO. 1340

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN THE NEW  
CONTRACT OF LEASE WITH THE EV TRANCO PANTRANCO OVER LANE NO.  
1 AND OFFICE SPACE AT TERMINAL BUILDING NO. 2 FOR A PERIOD OF  
ONE YEAR EFFECTIVE AS OF JANUARY 1, 1983.

"WHEREAS, the City Legal Officer has prepared the new Contract  
of Lease and is already signed by the Proprietor/Manager of the EV  
Tranco Pantranco covering the latter's utility of Lane No. 1 and  
office space of Terminal Building No. 2 at the waterfront with a  
monthly rental of One Thousand Nine Hundred Pesos (P1,900.00) ef-  
fective as of January 1, 1983, to cover a period of one year, which  
contract awaits the signature of His Honor, the City Mayor, for all  
intents and purposes; thereof;
