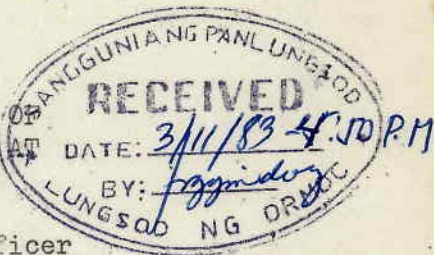

A RESOLUTION TO AUTHORIZE THE CITY TREASURER TO CHARGE AGAINST THE

PLANNING AND DEVELOPMENT STAFF THE SUM OF P1,043.50 TO SETTLE
OUTSTANDING OBLIGATIONS ON SAID ITEM INCURRED LAST YEAR
