RESOLUTION NO. 1342

A RESOLUTION AUTHORIZING HON. DIONISIO B. TORREVILLAS, CHAIRMAN,
POLICE, FIRE AND PUBLIC SAFETY COMMITTEE, TO REPRESENT THE
SANGGUNIANG PANLUNGSOD NG ORMOC IN THE 10TH NATIONAL FIRE
SAFETY CONVENTION IN METRO MANILA ON MARCH 24-25, 1983

"WHEREAS, the Safety Organization of the Philippines, Inc. (SPOI),
in cooperation with the Integrated National Police (INP), is sponsoring
the 10th National Fire Safety Convention in Makati, Metro Manila, sche-
