A RESOLUTION EARNESTLY REQUESTING AUTHORITY FROM THE OFFICE OF
THE BUDGET AND MANAGEMENT FOR ORMOC CITY TO PURCHASE NECESS-
SARY EQUIPMENT PER BUDGET CIRCULARS 15 AND 15-A

"WHEREAS, the City Administration has been waging a peace and
order campaign and to make it more effective this august Body finds
it urgent that the City Government should buy some necessary equip-
ment to be made available for the city officials and the police in
the course of their campaign specially in the rural areas;

"WHEREAS, there is more than sufficient fund for this purpose
such as from the Infrastructure Fund where there is still an unap-
propriated balance of P160,000.00 as shown in our city books;

"NOW, THEREFORE, on motion of Kagawad Besabella, seconded by
Kagawad Tugonon; be it

"RESOLVED, to earnestly request authority from the Office of
the Budget and Management for the City of Ormoc to purchase neces-
sary equipment per Budget Circulars 15 and 15-A to carry out its
peace and order campaign and other socio-economic development pro-
grams; and be it

"RESOLVED, FURTHER, that copies of this resolution be furnish-
ed, through the City Budget Officer, to the Honorable Minister of the
Budget, the Regional Director, Ministry of the Budget, and the Office
of the Budget and Management; and, also, to the City Treasurer and
the City Engineer, of this city;
