RESOLUTION NO. 1344

A RESOLUTION EARNESTLY REQUESTING REGIONAL DIRECTOR OF PUBLIC WORKS AND HIGHWAYS TO KINDLY INTERVENE IN THE CURRENT "ORMOC-MERIDA ROAD DEVELOPMENT PROJECT" UNDERTAKEN BY THE HI-TRI CONSTRUCTION CORPORATION WITHOUT THE BENEFIT OF NOTIFICATION AND COORDINATION WITH THE OFFICE OF THE CITY ENGINEER OF ORMOC CITY.

"WHEREAS, the Hi-Tri Construction Corporation has been undertaking the on-going 'Ormoc-Merida Road Development Project' for quite a while now without such courtesy or even benefit of notification and coordination with the Office of the City Engineer as if the latter is not existing in the City of Ormoc;

"WHEREAS, there is an urgency to call the attention of the Hi-Tri Construction Corporation in this regard considering that at this stage of its project the drainage of Barangay San Isidro is greatly affected by their operation;

"NOW, THEREFORE, on motion of Kagawad Torrevillas, seconded jointly by Mga Kagawad Bandalan, Santiago and Hermosilla; be it

"RESOLVED, to earnestly request the Regional Director of Public Works and Highways for his kind intervention in the current 'Ormoc-Merida Road Development Project' undertaken by the Hi-Tri Construction Corporation without the benefit of notification and coordination with the Office of the City Engineer of Ormoc City; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to Engr. Benedicto E. Perez, Regional Director, Ministry of Public Works and Highways, Region VIII, Candahug, Palo, Leyte; The City Engineer and the General Manager, Hi-Tri Construction Corporation, both in Ormoc City;
