RESOLUTION NO. 1345

RESOLUTION AUTHORIZING THE CITY TREASURER TO RELEASE THE SUM OF  
P3,327.00 OUT OF THE ITEM ON SPORTS DEVELOPMENT TO BE MADE  
AVAILABLE FOR AID TO THE CITY FEDERATION OF KABATAANG BARANGAYS  
TO DEFRAY TRAVEL AND TRANSPORTATION EXPENSES OF PARTICIPANTS IN  
THE KB REGIONAL SPORTS MANAGEMENT TRAINING SEMINAR AND THE KB  
REGIONAL CHESS TOURNAMENT IN TACLOBAN CITY, March 23-28, 1983.

"WHEREAS, the Honorable Maria Emily C. Codilla, President of  
the City Federation of Kabataang Barangays, manifested that the  
Federation is sending seven (7) participants to the KB Regional  
Sports Management Training Seminar scheduled for March 23-26, 1983,  
as authorized by Regional Memo Circular No. 8301 dated March 3, 1983,  
and, also, six (6) participants to the KB Regional Chess Tournament,  
March 23-28, 1983, both in Tacloban City, which would entail the sums  
of P1,703.00 and P1,624.00, respectively, for their travel and trans-  
portation expenses;

"NOW, THEREFORE, on motion of Kagawad Codilla, seconded by Kaga-  
wad Samson; be it

"RESOLVED, to authorize the City Treasurer to release the aggre-  
gate sum of P3,327.00 out of the item on Sports Development to be made  
available for aid to the City Federation of Kabataang Barangays to  
defray travel and transportation expenses of participants in the KB  
Regional Sports Management Training Seminar and the KB Regional Chess  
Tournament in Tacloban City, March 23-28, 1983; and be it

the City Treasurer, the City Budget Officer, and the President, City  
Federation of Kabataang Barangays, all of this city;
