RESOLUTION NO. 1349

A RESOLUTION EARNESTLY REQUESTING BRIG. GEN. CESAR VILLARIN, PC
RECOM 8 COMMANDER, AND COL. VICENTE GARCIA, PC PROVINCIAL
COMMANDER OF LEYTE, FOR CIVAC SUPPLIES AND MATERIALS TO BE
MADE AVAILABLE FOR THE CIVIC ACTION PROGRAM FOR THE BARANGAYS
OF ORMOC UNDER THE AUSPICES OF THE CITY ADMINISTRATION
SCHEDULED FOR APRIL 4 TO 8, 1983.

"WHEREAS, the City Administration, in another gesture of bring-
ing the Government closer to the people, is launching a civic action
program for the general well-being of the barangay people of Ormoc
scheduled for April 4 to 8, 1983;

"WHEREAS, to carry out this program we need the kind assistance

the Civic Action Program for the barangays of Ormoc City scheduled
for April 4 to 8, 1983; and be it
