RESOLUTION NO. 1350

A RESOLUTION EARNESTLY REQUESTING THE ORMOG MEDICAL SOCIETY FOR
MEDICAL SUPPLIES AND MANPOWER TO BE MADE AVAILABLE FOR THE
CIVIC ACTION PROGRAM FOR THE BARANGAYS OF ORMOG UNDER THE
AUSPICES OF THE CITY ADMINISTRATION SCHEDULED FOR APRIL
4 TO 8, 1983.

"WHEREAS, the City Administration, in another gesture of bring-
ing the Government closer to the people, is launching a civic action
program for the benefit and welfare of the barangay people scheduled
for April 4 to 8, 1983;

"WHEREAS, to carry out this program we need the kind assistance
of the Ormoc Medical Society, among other civic organizations, by
way of providing us with the necessary medical supplies and manpower
available for the purpose;

Action Program for the barangays of Ormoc under the auspices of the
City Administration scheduled for April 4 to 8, 1983; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each
to Dr. Rogelio C. Dejaño, President, Ormoc Medical Society, and Dr.
Rogelio G. Marson, City Health Officer, both of Ormoc City;
