RESOLUTION NO. 1354

A RESOLUTION APPROVING THE FIVE-YEAR (1983-1987) CLUSTER DEVELOPMENT PLAN OF BARANGAYS TAMBULILID, PUNTA, LINAOG, NAUANGAN AND DOÑA FELIZA Z. MEJIA (TAMPULINAD) AND AUTHORIZING ITS IMPLEMENTATION, AS SUBMITTED BY THE CITY DEVELOPMENT OFFICER.
