RESOLUTION NO. 1356

A RESOLUTION TO AUTHORIZE THE CITY TREASURER TO RELEASE THE AGGREGATE SUM OF P140,000.00 OUT OF THE CONTINUING APPROPRIATION FOR EXPROPRIATIONS IN THE INFRASTRUCTURE FUND TO BE MADE AVAILABLE FOR PAYMENT TO ATTY. & MRS. ALBINO P. PORCADILLA AND MR. & MRS. ROMULO P. PORCADILLA FOR THEIR HOUSES AND LOT ON SAN PEDRO STREET IN CONSONANCE WITH THE DECISION DATED MARCH 18, 1983, OF THE REGIONAL TRIAL COURT OF ORMOC CITY.

"The Sangguniang Panlungsod ng Ormoc, on motion of Kagawad Mendola, seconded jointly by Mga Kagawad Torrevillas, Bandalan and Santiago;

"RESOLVED, to authorize the City Treasurer to release the aggregate sum of ONE HUNDRED FORTY THOUSAND PESOS (P140,000.00) out of the continuing appropriation for expropriations in the Infrastructure Fund, said sum or so much thereof as may be necessary to be made available for payment, in consonance with the decision dated March 18, 1983, of the Regional Trial Court of Ormoc City, to wit:

- (a) To Atty. & Mrs. Albino P. Porcadilla for their residential building under Tax Declaration No. 99610 P100,000.00
(b) To Mr. & Mrs. Romulo P. Porcadilla for their residential Lot No. 12545 under O.C.T. P-628 of 90 square meters and residential house, both properties covered by Tax Declaration No. 99626 P 40,000.00;
all situated on San Pedro Street, Ormoc City;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the City Treasurer, The City Engineer, the City Budget Officer, Atty. & Mrs. Albino P. Porcadilla, and Mr. & Mrs. Romulo P. Porcadilla, all in the City of Ormoc;
