A RESOLUTION TO AUTHORIZE THE CITY TREASURER TO CHARGE AGAINST
CURRENT APPROPRIATION ON FUELS, OILS AND SPARE PARTS IN THE
INFRASTRUCTURE FUND P350.00 TO SETTLE OUTSTANDING OBLIGA-
TIONS WITH BEN'S BATTERY SHOP FOR LABOR AND MATERIALS FOR
REWINDING PAYLOADER'S STARTER ASSEMBLY ARMATURE.
