RESOLUTION NO. 1359

A RESOLUTION AUTHORIZING THE FEDERATION OF KABATAANG BARANGAYS OF
ORMOC, UNDER THE CHAIRMANSHIP OF FKB PRESIDENT MA. EMILY C.
CODILLA, TO MANAGE THE 1983 ORMOC CITY FESTIVAL CELEBRATION

"WHEREAS, in our desire to project our youth once more to the
limelight through a meaningful social, civic and economic undertak-
ing, the City Administration would like to give the Federation of
Kabataang Barangays another try in the management of our city fes-
tival celebration come June 20 to July 4, this year, under the
overall chairmanship of its young and energetic president, the
Honorable Ma. Emily C. Codilla, with the backing, of course, of
the Administration for a successful fiesta affair:

"NOW, THEREFORE, on motion of Kagawad Samson, seconded joint-
ly by all the other Mga Kagawad, except the Honorable Ma. Emily C.

"RESOLVED, to authorize the Federation of Kabataang Barangays,
