RESOLUTION NO. 1360

A RESOLUTION URGENTLY REQUESTING HIS EXCELLENCE, PRESIDENT FERNANDO E. MARCOS, TO EXTEND ASSISTANCE TO DROUGHT-INFESTED ORMOC CITY TO ALLEVIATE PEOPLE'S PROBLEMS OF DEHYDRATED PLANTS AND DRYING OUT AGRICULTURAL LANDS

"WHEREAS, Ormoc City has been bearing the brunt of the longest drought that ever infested hereabout to the great damage or ruins of crops and vegetations such that both farmers and consumers or the public in general are now besieged with mounting problems that almost drive them to despair for want of rain to water our dying plantations;

"NOW, THEREFORE, on motion of Kagawad Hermosilla, seconded unanimously by all the other Nga Kagawad present; be it

"RESOLVED, to urgently request His Excellency, President Ferdinand E. Marcos, to extend assistance to drought-infested Ormoc City in order to alleviate the people's problems of dehydrated plants and drying out agricultural lands; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to His Excellency, President Ferdinand E. Marcos, Malacañang, and Hon. Arturo F. Tanco, Minister of Agriculture, Quezon City, both in Metro Manila;

"CARRIED UNANIMOUSLY."
