RESOLUTION NO. 1361

A RESOLUTION TO AUTHORIZE THE CITY TREASURER TO RELEASE THE SUM OF
NINETEEN THOUSAND PESOS (P19,000.00) OUT OF THE GENERAL FUND
ITEM ON RELOCATION OF SQUATTERS TO BE MADE AVAILABLE FOR AID
IN THE RELOCATION OF SQUATTERS OF THE CITY SLAUGHTERHOUSE AND
LIVESTOCK MARKET AREA IN BARANGAY ALEGRIA TO THE RESETTLEMENT
SITE IN BARANGAY BAGONG BUHAY, ORMO^C CITY

"WHEREAS, the squatters of the city slaughterhouse and livestock
market area in Barangay Alegria have already agreed to be resettled in
Barangay Bagong Buhay for which the City Administration has committed
itself to assist the former in moving out to the resettlement site;

"NOW, THEREFORE, on motion of Kagawad Mendola, seconded jointly
by Mga Kagawad Samson and Bandalan; be it

"RESOLVED, to authorize the City Treasurer to release the sum
of Nineteen Thousand Pesos (P19,000.00) out of the item on reloca-
tion of squatters in the General Fund, said sum or so much thereof
as may be necessary to be made available for aid in the relocation
of squatters of the city slaughterhouse and livestock market area in
Barangay Alegria to the resettlement site in Barangay Bagong Buhay;

"RESOLVED, FURTHER, to furnish a copy of this resolution each
to the City Treasurer, the City Engineer, the City Veterinarian,
and the Punong Barangays of Alegria and Bagong Buhay, all in the
City of Ormoc;
