RESOLUTION NO. 1363

A RESOLUTION TO AUTHORIZE THE CITY TREASURER TO CHARGE AGAINST
CURRENT APPROPRIATION ON AID TO COURT OF FIRST INSTANCE THE
SUM OF P2,027.48 TO SETTLE OUTSTANDING OBLIGATIONS OF THE
SAID COURT WITH LEYECO V INCURRED FROM DECEMBER, 1980, UP
TO DECEMBER, 1982, ON ELECTRICITY

"The Sangguniang Panlungsod, on motion of Kagawad Besabella, se-
conded jointly by Mga Kagawad Mendola and Santiago;

"RESOLVED, to authorize the City Treasurer to charge against the
current appropriation on Aid to Court of First Instance the sum of Two
Thousand Zero Twenty-Seven & 48/100 Pesos (P2,027.48), said sum or so
much thereof as may be necessary to be made available for settling out-
standing obligations of the defunct Court of First Instance (now Regio-
nal Trial Court) on electricity incurred from December, 1980, up to and
including December, 1982, with LEYECO V; and

"RESOLVED, FURTHER, to furnish a copy of this resolution each to
the City Treasurer, the Presiding Judge, Regional Trial Court, and the
General Manager, LEYECO V, all in Ormoc City;

"CARRIED UNANIMOUSLY."
