RESOLUTION NO. 1364

A RESOLUTION TO AUTHORIZE THE HONORABLE CITY MAYOR TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE MINISTRY OF ENERGY OVER 31 HECTARES OUT OF LOT NO. 10851 SITUATED IN CAMBANTUG, MILAGRO, ORMOC CITY, BEING SOLICITED WITH THE BUREAU OF LANDS FOR THE ESTABLISHMENT OF THE ORMOC CITY NURSERY THEREON WHICH IS INCORPORATED IN THE "PAGKAIN NG BAYAN" PROGRAM OF MADAM IMELDA ROMUALDEZ—MARCOS AND IN LINE WITH THE "KKK" PROGRAM

"WHEREAS, in 1981 this august Body passed four resolutions, namely: Resolution No. 922 implementing the Food Production Program of the "Pagkain ng Bayan" launched by the Honorable First Lady and Human Settlements Minister, Madam Imelda-Romualdez Marcos, to be integrated in our Vegetable Mursery Farm at Cambantug, Milagro, Ormoc City; Resolution No. 999 expressing the intention of Ormoc City Government in soliciting 31 hectares out of Lot No. 10851 situated in Cambantug, Milagro, Ormoc City, for the establishment of the Ormoc City Nursery thereon; Resolution No. 1058 authorizing the Honorable City Mayor to sign a lease application with the Bureau of Lands covering the said portion of land for purposes of the city nursery; and Resolution No. 1086 earnestly requesting the Regional Director of Lands to expedite the approval of our lease application for the 31 hectares as already surveyed and segregated by the Bureau for purposes of the city nursery incorporated in Mrs. Marcos! "Pagkain ng Bayan" program;

"WHEREAS, last year (1982) this same Body passed two more resolutions, namely: Resolution No. 1099 earnestly requesting the Manager of Leyte Geothermal Project to favorably recommend the release of the 31-hectare portion of Lot No. 10851 in Cabingtan, Ormoc City, under the City's lease application with the Bureau of Lands for purposes of the "Pagkain ng Bayan" project and for vegetable nursary in line with the need of the KKK programs of Ormoc City; and Resolution No. 1187 earnestly requesting President Ferdinand E. Marcos to release the area under lease application of the City Government for purposes of the dity nursery and for the integration and prosecution of the "Pagkain ng Bayan" project in line with the "Kilusang Kabuhayan at Kaunlaran" (KKK) program;

"WHEREAS, after quite a long while we are now in receipt of a communication of the Acting District Land Officer informing us that in view of the memorandum of Minister Teodoro Peña of Natural Resources turning over to the Ministry of Energy the responsibility for the protection, management, development and rehabilitation of the Leyte Geothermal Reservation, his office lost jurisdiction to act on the Agricultural Lease Application of Ormoc City for the subject tract of land which area is inside the Leyte Geothermal Reservation but, nevertheless, we may still be able to avail of

the use of the said area by entering into a memorandum of agreement with the Ministry of Energy to that effect, a copy of which memorandum of agreement the Acting District Land Officer would like to be furnished his office to support the approval of the survey conducted by the latter sometime in August, 1981; and

"NOW, THEREFORE, on motion of Kagawad Tugonon, seconded jointly by Mga Kagawad Mendola and Santiago; be it

"RESOLVED, to authorize the Honorable City Mayor to enter into a Memorandum of Agreement with the Ministry of Energy over thirty-one (31) hectares out of Lot No. 10851 situated in Cambantug. Milagro, Ormoc City, being solicited with the Bureau of Lands who have already surveyed and segregated the particular area for the establishment of the Ormoc City Nursery thereon which is incorporated in the "Pagkain ng Bayan" program of Madam Imelda Romualder-Marcos and in line with the "Kilusang Kabuhayan at Kaunlaran" (KKK) program; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to Hon. Teodoro Peña, Minister of Natural Resources, Quezon City, Metro Manila; Hon. Imelda Romualdez-Marcos, Minister of Human Settlements, Malacañang, Manila; Engr. Felipe S. Sison, Acting District Land Officer, Bureau of Lands, Tacloban City; and Engr. Ernesto B. Patanao, General Manager, Tuñgonan Geothermal Project, Ormoc City;
