RESOLUTION NO. 1367

A RESOLUTION MOST RESPECTFULLY REQUESTING HIS EXCELLENCY, PRESIDENT FERDINAND E. MARCOS, THROUGH THE MONORABLE LOCAL GOVERNMENT MINISTER JOSE A. RONO, TO KINDLY RESTORE THE GRANT OF REPRESEN-TATION ALLOWANCES TO THE CITY VICE MAYOR AND THE MEMBERS (MGA KAGAWAD) OF THE SANGGUNIANG PANLUNCSOD OF ORMOC CITY PURSUANT TO MEMORANBUM CIRCULAR NO. 437 DATED FEBRUARY 21, 1971 OF THE OFFICE OF THE PRESIDENT. AT P350.00 PER MONTH EACH.

"WHEREAS, with the abolition of the Municipal Board and, forthwith, the establishment of the Sangguniang Panlungsod of Ormoc City pursuant to Presidential Decree No. 826 the grant of representation allowances to the City Vice-Mayor and the Members of this legislative body, among others, pursuant to Memorandum Circular No. 437 dated February 22, 1971, of the Office of the President, had been cut off;

"WHEREAS, there never has been a more pressing need than today for representation allowances by the Vice-Mayor and Presiding Officer and the Members (Mga Kagawad) of the Sangguniang Panlungsod taking into account the numerous attentions and multifarious functions adherent to their respective positions in services rendered along their sworn duties and responsibilities as in the reception and entertainment of official guests and contributions to socio-economic development projects of private organizations, and many more;

"WHEREAS, the grant of monthly representation allowances for the aforementioned elective officials will not affect the stability of the city general fund exclusive of amounts earmarked for vital local services even as the amount involved shall be included in the determination of the allowable percentage for salaries and wages under the provisions of existing laws, while the city has complied and provided for all its statutory and contractual obligations without incurring any overdraft as a result of the granting of the said allowances which shall be strictly on reimbursement basis in compliance with Memorandum Circular No. 437 above cited;

Roño, to kindly restore the grant of representation allowances to the City Vice-Mayor and the Members (Mga Kagawad) of the Sangguniang Panlungsod of Ormoc City pursuant to Memorandum Circular No. 437 dated February 22, 1971, of the Office of the President, at P350.00 per month each; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to His Excellency, President, Ferdinand E. Marcos, Malacanang, Hon. Jose A. Roño, Minister of Local Government, New QC Hall, Quezon City, Hon. Francisco Tantuco, Chairman, Commission on Audit, all in Metro Manila;
