RESOLUTION NO. 1371

A RESOLUTION EARNESTLY REQUESTING OUR ASSEMBLYMEN OF REGION VIII TO JOINTLY SPONSOR A BILL CONVERWING ORMOC MUNICIPAL PORT INTO A NATIONAL PORT

"WHEREAS, the Assistant Executive Officer of the Philippine Ports Authority, to whom was referred by the Ministry of Public Works and Highways our Resolution No. 1299 requesting the conversion of Ormoc municipal port into a national port, has informed the Honorable Vice-Mayor and Presiding Officer in his letter of 08 April 1983 that such conversion requires an act of the Batasang Pambansa or an executive order of the President;

"WHEREAS, the Ormoc wharf which is of vintage 1937 has undergone several extensions and repairs only to be damaged with the passage of time under stress and strain of heavy volume of coastwise and export trade and while its supporting bars are already exposed to the elements we are gripped with fear and apprehension that in no time it will collapse;

"WHEREAS, it would best serve the interests of our people in these parts of the region through navigation hand in hand with trade, commerce, industry and the like if the Ormoc municipal port were converted into a national port considering the progress of the coastwise and export trade presently handled, not to mention the increasing number of ships calling at this port with the establishments of industrial plants, commercial houses and other business enterprises due to the harnessing of Tungonan hot springs as a geothermal power source;

"WHEREAS, following the advice of the Assistant Executive Officer of the Philippine Ports Authority it behooves this august Body somehow to turn its needs to our assemblymen of the region with the fervent hope that at long last our pleadings will bear fruition for the conversion of the Ormoc municipal port into a national port;

"NOW, THEREFORE, on motion of Kagawad Larrazabal, seconded unanimously by all the rest of the Kagawads; be it

"RESOLVED, to earnestly request our Assemblymen of Region VIII to jointly sponsor a bill in the Batasang Pambansa converting Ormoc municipal port into a national port; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to our assemblymen of Region VIII: Hon. Jose A. Roño, Hon. Emiliano Melgazo, Hon, Alberto A. Veloso, Hon. Fernando F. Veloso, Hon. Artemio Mate, Hon. Damian Aldaba, Hon. Edilberto del Valle, Hon. Victor Amasa and Hon. Nicanor Yñiguez, all in Batasang Pambansa, Quezon City, Metro Manila;
