RESOLUTION NO. 1373

A RESOLUTION EARNESTLY REQUESTING THE PRESIDENT AND THE FIRST
LADY TO KINDLY ADVISE THE NATIONAL POWER CORPORATION TO
ROLL BACK ITS RATE IN LEYECO V AREA BASED ON THE GEOTHERMAL
POWER CONSIDERING THAT THE POWER BARGE IS ALREADY WITHDRAWN

"WHEREAS, when the power barge service was engaged although not
at all necessary, member-consumers of Leyte V Cooperative (LEYECO V),
Inc., were slapped an increase of rate from P0.65 to P1.07 per kilo-
watt-hour because of the fuel cost but now that the power barge had
already been disengaged and withdrawn the increased rate still remains;

"WHEREAS, it is quite unfair for LEYECO V to charge its members
the same increased rate when the power barge had already been disen-
gaged and terminated;

"NOW, THEREFORE, on motion of Kagawad Larrazabal, seconded una-
nimously by all the rest of the Kagawads; be it

"RESOLVED, to earnestly request the President and the First Lady
to kindly advise the National Power Corporation to roll back its rate
in LEYECO V area based on the geothermal power considering that the
power barge had already been withdrawn from the area; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to
His Excellency, President Ferdinand E. Marcos, and the Honorable First
Lady, Madam Imelda Romualdez-Marcos, Malacañang, Hon. Gabriel Y. Itchon,
President, National Power Corporation, Quezon Ave. cor. BIR Road, Dili-
man, C.C., all in Metro Manila; Engr. Brigido Ordoña, Project Engineer,
NPC, Mr. Rosalino M. Culalic, General Manager, and Mr. Climaco Evange-
lista, President, Board of Directors, LEYECO V, all in Ormoc City;
