RESOLUTION NO. 1374

A RESOLUTION DEMANDING FROM THE NATIONAL POWER CORPORATION AND THE NATIONAL ELECTRIFICATION ADMINISTRATION A ROLL BACK OF THE RATES IN LEYECO V AREA BASED ON THE GEOTHERMAL POWER AFTER THE POWER BARGE HAD ALREADY BEEN WITHDRAWN FROM THE AREA.

"WHEREAS, despite the fact that the power barge had already been disengaged and withdrawn from the area under the Leyte V Electric Cooperative (LEYECO V), Inc., the member-consumers are still being charged P1.15 per kilowatt hour instead of P0.65 based on the geothermal power;

"WHEREAS, justice and equity demand that the rate of LEYECO V be rolled back from P1.15 to P0.65 per kilowatt hour based on the aforementioned geothermal power considering that no more fuel cost is involved in the operation;

"NOW, THEREFORE, on motion of Kagawad Samson, seconded unanimously by all the rest of the Kagawads; be it

"RESOLVED, to demand from the National Power Corporation and the National Electrification Administration a roll back of the rates in LEYECO V area based on the geothermal power after the power barge had already been withdrawn from the area; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to Hon. Gabriel Y. Itchon, President, National Power Corporation, Quezon Ave. cor. BIR Road, Dilliman, and Col. Pedro Dumol, Administrator, National Electrification Administration, 10050 Quezon Ave., both in Metro Manila; Engr. Brigido Ordoña, Project Manager, NPC, Mr. Rosalino M. Culalic, General Manager, and Mr. Climaco Evangelista, both of LEYECO V, and all in Ormoc City;

"CARRIED UNANIMOUSLY."
