RESOLUTION NO. 1375

A RESOLUTION AUTHORIZING THE ENERGY DEVELOPMENT AND CONSERVATION COMMITTEE OF THE SANGGUNIANG PANLUNGSOD NG ORMOC TO MAKE A STUDY, SURVEY AND RESEARCH JOINTLY, IF POSSIBLE, WITH ANY ELECTRICAL ENGINEER OR TECHNICIANS DUE TO SEVERAL COMPLAINTS OF INEFFICIENT PERFORMANCE OF LEYECO V MANAGEMENT.

"WHEREAS, this august Body has been always flooded with complaints verbally by telephone and personally every time there is power failure or breakdown without prior notice or warning by the LEYECO V management so much so that member-consumers are beginning to question or doubt its efficiency in the performance of its duties and responsibilities for the benefit and welfare of said consumers;

"WHEREAS, a great number of member-consumers has been earnestly requesting the City Administration to do something for them that the service of LEYECO V shall once and for all be improved to their entire satisfaction;

"NOW, THEREFORE, on motion of Kagawad Hermosilla, seconded unanimously by all the rest of the Kagawads; be it

"RESOLVED, to authorize the Energy Development and Conservation Committee of the Sangguniang Panlungsod ng Ormoc to make a study, survey and research jointly, if possible, with any electrical engineer or technicians due to the several complaints of inefficient performance rendered by the LEYECO management aired by the member-consumers; and

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the General Manager, the President of the Board of Directors, both of LEYECO V, and the Committee: Hon. Romeo M. Hermosilla, Chairman, Hon. Dionisio S. Santiago, Vice-Chairman, Hon. Dionisio B. Torrevillas, Hon. Jose O. Bandalan and Hon. Iñaki P. Larrazabal, Jr., Members, all in Ormoc City;
