RESOLUTION NO. 1377

A RESOLUTION TO AUTHORIZE THE HONORABLE CITY MAYOR TO ACCEPT 12
20-WATT FLOURESCENT LAMPS DONATION OF THE BARANGAY SANGGUNIANG
OF SAN ISIDRO FOR INSTALLATION THEREIN SUBJECT TO RESOLUTION
NO. 1149 DATED APRIL 20, 1982, ON BARANGAY WATTAGE LIMITATION

"WHEREAS, the Sangguniang Barangay of San Isidro by its Resolution
No. 1 dated April 28, 1983, manifested its desire to donate a dozen 20-
watt flourescent lamps to be installed on electric posts in the barangay
of which the barangay sanggunian would like the Mayor's acceptance;

"NOW, THEREFORE, on motion of Kagawad Hermosilla, seconded by Kaga-
wad Bandalan; be it

"RESOLVED, to authorize the Honorable City Mayor to accept twelve
(12) units of 20-watt flourescent lamps donation of the Barangay Sanggu-
nian of San Isidro for installation on electric posts in the said baran-
gay subject, however, to Resolution No. 1149 dated April 20, 1982, on
wattage limitation for every barangay to only 250 watts, otherwise, any
wattage in excess thereof shall be shouldered by the barangay out of its
10% realty tax shares or any other source of barangay fund; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to
the Sangguniang Barangay of San Isidro, the General Manager and the Pre-
sident of the Board of Directors, LEYECO V, the City Treasurer and the
City Engineer, all in Ormoc City;

"CARRIED UNANIMOUSLY."
