RESOLUTION NO. 1382

A RESOLUTION TO INQUIRE FROM THE MARITIME INDUSTRY AUTHORITY AS TO THE RESULT OF ITS ADMONITION FOR ABOITIZ SHIPPING CORPORATION TO UNDERTAKE CORRECTIVE MEASURES FOR A BETTER QUALITY OF SERVICE.

"WHEREAS, this august Body will remember having been furnished a copy of the letter dated 16 June 1982 of the Maritime Industry Authority addressed to the Aboitiz Shipping Corporation following the investigation conducted by the Office of Domestic Shipping through the Cebu Maritime District Office on the malpractices and sub-standard quality of service of the said shipping firm;

"WHEREAS, in the said communication of the MARINA, we have gathered that the Aboitiz Shipping Corporation has been given a three-month period within which to undertake corrective measures, failing which, other operators shall be allowed to service the route to enable the public to receive or avail themselves of better service;

"WIDEREAS, despite the foregoing admonition we believe that nothing tangible has been made so far by the Aboitiz Shipping Corporation inasmuch as the commuting public is still clamoring for better service even as passengers still complain of (1) small cots still in existence causing discomfort for passengers in their sleep; (2) narrow passengers between cots; (3) double issuance of tickets for one and the same cot; and many other inconveniences during navigation;

"NOW, THEREFORE, on motion of Kagawad Samson, seconded unanimously by all the other Mga Kagawad; be it

"RESOLVED, to inquire from the Maritime Industry Authority as to the result of its admonition for the Aboitiz Shipping Corporation to undertake corrective measures for a better quality of service along the Ormoc-Cebu, Ormoc-Manila and Ormoc-Surigao routes; and be it
