RESOLUTION NO. 1383

A RESOLUTION INTERPOSING NO OBJECTION TO MAMERTA G. VDA. DE GERALDO'S
REQUEST FOR SURVEY AUTHORITY OVER 1.5 HAS. OF LAND IN BARANGAY
MABINI, ORMOC CITY, AS IT DOES NOT AFFECT ANY PUBLIC IMPROVEMENT

"WHEREAS, the Acting District Land Officer has requested information as to whether or not the occupation of 1.5 hectares of land in Barangay Mabini, this city, applied for survey authority by Mamerta Gayo vda. de Geraldo will not be detrimental to the interest of the Government and affect any public improvement;

"WHEREAS, the Punong Barangay of Mabini was immediately called for a conference by the Kagawad In-Charge who reported that the Barangay has no need for such land and, besides, the land has already been in the possession of the applicant for quite a number of years now; and the use of the land does not in any way affect any public improvement in Mabini;

"NOW, THEREFORE, on motion of Kagawad Besabella, seconded by Kagawad Hermosilla; be it

"RESOLVED, to interpose no objection to the application or request for survey authority over 1.5 hectares of land in Barangay Mabini, Ormoc City, by Mamerta Gayo vda. de Geraldo inasmuch as it does not affect any public improvement in the said barangay; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the District Land Officer, Bureau of Lands District Land Office No. VIII-I, Tacloban, City, the City Engineer, the Punong Barangay of Mabini, and Mrs. Mamerta Gayo vda. de Geraldo, all in Ormoc City;
