RESOLUTION NO. 1387

A RESOLUTION EARNESTLY REQUESTING ALL CITY OFFICIALS AND EMPLOYEES
TO CONTRIBUTE TWO PERCENT (2%) OF THEIR ONE-MONTH SALARIES BUT
NOT LESS THAN TEN PESOS (P10.00) FOR THE PERIOD FROM MAY
16 TO JUNE 15, 1983, FOR THE ORMOC CITY FESTIVAL OF 1983

"WHEREAS, the 1983 Ormoc City Festival (June 19-July 4) is just
around the corner and to make it a stunning success it is but neces-
sary that every man, woman and child should cooperate in this under-
taking where it has been the practice for government officials and
employees, including school officials and teachers, to chip in their
share of the financial burden for this traditional celebration;

"NOW, THEREFORE, on motion of Kagawad Besabella, seconded by
Kagawad Santiago; be it

"RESOLVED, to earnestly request all city officials and employees,
as well as school officials and teachers, to contribute two percent
(2%) of their one-month salaries but not less than ten pesos (P10.00)
for the period from May 16 to June 15, 1983, and do, as this Body here-
by does, request them, further, to evince in writing their desire to
so contribute in the forthcoming city fiesta; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each to
all department heads, city and national offices, in the City of Ormoc;
"CARRIED UNANIMOUSLY."
