A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO ACCEPT 13 UNITS OF FLOURESCENT LAMPS WITH ACCESSORIES DONATED BY THE SANGGUNIANG BARANGAY OF SABANG BAO FOR INSTALLATION ON THE BARANGAY STREETS. SUBJECT TO RESOLUTION NO. 1149 ON BARANGAY WATTAGE LIMITATION

"WHEREAS, the Sangguniang Barangay of Sabang Bao by its Resolution No. 10, current series, had signified its intention to donate 13 units of flourescent lamps with accessories for installation on the streets of the barangay conscious, however, of the 250-watt limitation for every babangay consumption to be shouldered by the City as provided in our Resolution No. 1149;

"RESOLVED, to authorize the Honorable City Mayor to accept 13 units of flourescent lamps with accessories donated by the Sangguniang Barangay of Sabang Bao for installation on the barangay streets subject, however, to Resolution No. 1149 on Barangay wattage limitation of 250 and any excess thereof shall be shouldered by the barangay out of its 10% realty tax shares or other sources; and be it
