"WHEREAS, the Proprietor of the Madongolan Cockpit in his letter of May 23, 1983, has requested a resolution of this sangguni to authorize the Madongolan Cockpit to hold a four-day backfight/cockfight on June 27, 28, 29, 30, in connection with the 1983 Ormoc City Festival celebration in veneration of the people's beloved Patron, Saints Peter and Paul;
