A RESOLUTION TO AUTHORIZE THE CITY TREASURER TO CHARGE AGAINST THE  
CURRENT APPROPRIATIONS ON POWER AND ILLUMINATION THE SUM OF TWO  
THOUSAND ZERO EIGHTY-EIGHT & 37/100 PESOS (P2,088.37) TO SETTLE  
OUTSTANDING OBLIGATIONS INCURRED NOVEMBER AND DECEMBER, 1982.

e) Ormoc City High School - - - - -	19.60
f) M S S D, Ormoc Branch - - - - -	19.62
