RESOLUTION NO. 1395

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO ACCEPT FIVE
20-WATT FLUORESCENT LAMPS DONATED BY THE SANGGUNIANG BARANGAY
OF ALEGRIA FOR INSTALLATION WITHIN THE BARANGAY, SUBJECT TO
RESOLUTION NO. 1149 ON BARANGAY WATTAGE LIMITATION.

"WHEREAS, the Sangguniang Barangay of Alegria by its Resolution
No. 13, current series, has signified its intention to donate five
20-watt fluorescent lamps for installation on strategic places in
the barangay;

"NOW, THEREFORE, on motion of Kagawad Samson, seconded by Kaga-
wad Mendola; be it

"RESOLVED, to authorize the Honorable City Mayor to accept five
units of 20-watt fluorescent lamps donated by the Sangguniang Baran-
gay of Alegria for installation within the barangay subject, however,
to the provision of Resolution No. 1149 dated April 20, 1982, on ba-
rangay wattage limitation to be shouldered by the City, otherwise,
any wattage in excess of 250 shall be shouldered by the Sangguniang
Barangay availing themselves of the 10% realty tax shares or any
other source of barangay fund; and be it

"RESOLVED, FURTHER, to furnish a copy of this resolution each
to the Punong Barangay of Alegria, the City Treasurer, the City En-
gineer, and the General Manager of LEYECO V, all in Ormoc City;
