RESOLUTION NO. 1397

A RESOLUTION MOST RESPECTFULLY REQUESTING THE KIND INTERCESSIONS OF  
THE HONORABLE MINISTERS IMELDA ROMUALDEZ-MARCOS OF HUMAN SETTLE-  
MENTS, AND GERONIMO VELASCO OF ENERGY, NPC PRESIDENT GABRIEL Y.  
ITCHON AND NEA ADMINISTRATOR PEDRO DUMOL FOR A BETTER AND  
EFFICIENT MANAGEMENT OF LEYECO V.

"WHEREAS, despite persistent complaints of member-consumers of  
unscheduled brownouts, extremely low voltage and other power brakes  
and failures nothing has been done, not even a semblance of service,  
by the LEYECO V management to remedy the situation such that damages  
to machineries and appliances worth hundreds of thousands of pesos  
have become inevitable much to the enormous ruin on the local econo-  
my;

"WHEREAS, the efficiency of LEYECO V management has gone down  
to its lowest ebb that the people of Ormoc, among others, are now in-  
dignant and, through this august Body, would like to ask for the in-  
tercessions of national officials for a better and efficient manage-  
ment of the cooperative, if not, an immediate relief of said management;

"NOW, THEREFORE, on motion of Kagawad Hermosilla, seconded unani-  
mously by all the other Kagawad present; be it

"RESOLVED, to most respectfully request the kind intercessions  
of the Honorable Ministers Imelda Romualdez-Marcos of Human Settle-  
ments and Geronimo Velasco of Energy, NPC President Gabriel Y. Itchon  
and NEA Administrator Pedro Dumol for a better and efficient manage-  
ment of LEYECO V and do, as this Body hereby does, reflect this reso-  
lution in telegrams to the above-named national personalities; and

Madam Imelda Romualdez-Marcos, Minister of Human Settlements, Malaca-  
ñang, Hon. Geronimo Velasco, Minister of Energy; Hon. Gabriel Y. It-

Diliman, Quezon City, and Gen. Pedro Dumol, Administrator, National  
Electrification Administration, 10050 Quezon Ave., Quezon City, all  
in Metro Manila; Mr. Rosalino M. Cuisalic, General Manager, and Mr.  
Climaco Evangelista, Board President, both of LEYECO V, Ormoc City;
