RESOLUTION NO. 1397

A RESOLUTION MOST RESPECTFULLY REQUESTING THE KIND INTERCESSIONS OF THE HONORABLE MINISTERS IMPLDA ROBUALDEZ-MARCOS OF HUMAN SETTLE-MENTS, AND GERONIMO VELASCO OF HUMANGI, NPC PRESIDENT GABRIEL Y. ITCHON AND MEA ADMINISTRATOR PEURO DUMOL FOR A BEATER AND EFFICIENT MANAGEMENT OF LEYECO V.

"WHEREAS, despite persistent complaints of member consumers of unscheduled brownouts, extremely low voltage and other power brakes and failures nothing has been done, not even a semblance of service, by the LEYECO V management to remedy the situation such that damages to machineries and appliances worth hundreds of theusands of pesos have become inevitable much to the enormous ruin on the local economy."

"MHEREAS, the efficiency of LEYECO V management has gone down to its lowest ebb that the people of Ormoc, among others, are now indignant and, through this august Body, would like to ask for the intercessions of national officials for a better and efficient management of the cooperative, if not, an immediate relief of said management;

"NOW, THEREFORE, on motion of Kagawad Hermosilla, seconded unanimously by all the other Mya Kagawad present; be it
