RESOLUTION NO. 1403

A RESOLUTION EARNESTLY REQUESTING CHAIRMAN EDUARDO Z. ROMUALDEZ
AND PRESIDENT ROMAN A. CRUZ, JR., OF THE PHILIPPINE AIR-
LINES TO CONSIDER THE RESUMPTION OF PAL FLIGHT SCHEDULES
TO ORMOC CITY

"WHEREAS, the Ormoc airport, after having been greatly developed
and immensely improved, is once again ever ready for service by the
Philippine Airlines domestic flights;

"WHEREAS, a series of survey has been conducted and it has been
found out that about forty percent (40%) of passengers at the Taclo-
ban airport comes from this side of Leyte, more specifically, the
officials and personnel of the Philippine Associated Smelting and
Refining (PASAR) Corporation in Isabel, Leyte, a neighboring muni-
cipality; the National Power Corporation (NPC) and the Philippine
National Oil Company (PNOC) both in Tugonon, Ormoc City, not to
mention the Ormoc City officials and personnel, businessmen, pro-
fessionals and merchants who commute to and from Manila more fre-
quently either via Cebu or Tacloban airport;

"WHEREAS, it is about time to reopen PAL flights in Ormoc City
considering the operations in high gear of the different industrial,
agricultural, commercial and other business establishments not only
in Ormoc City but also in the neighboring towns of Merida, Isabel,
Palompon, Albueria, Kananga and other nearby communities in view of
the development of the Tugonon geothermal power;

"WHEREAS, the opening of PAL flights in Ormoc will certainly
cater to the urgently needed fast and convenient travel of the ge-
neral public in this part of the province of Leyte;

"NOW, THEREFORE, on motion of Kagawad Tugonon, seconded una-
nimously by all the other Mga Kagawad present; be it

"RESOLVED, to earnestly request Chairman Eduardo Z. Romualdez
and President Roman A. Cruz, Jr., of the Philippine Airlines to
kindly consider the resumption of PAL flight schedules to Ormoc City;




